

INTRODUCTION OF BUSINESS

We are pleased to confirm that Britannia International Ltd ("the Bank") will be prepared to accept relevant business introduced to us by yourself/ves ("the Introducers") provided that you accept the following terms:

1. The Governing law of these terms will be the law of the Isle of Man.
2. The Bank reserves the right at its sole discretion to refuse to accept business from Introducers where we feel we are justified in doing so.
3. The Introducers will in no way be entitled to enter into negotiation on behalf of the Bank, or to bind the Bank in any way.
4. The acceptance of these terms will not create, or be deemed to create, a partnership or the relationship of employer and employee between the parties hereto.
5. This contains the entire agreement between the parties, and supersedes all previous agreements and understanding between the parties with respect thereto and may not be modified except by an instrument in writing signed by the duly authorised representative of both of the parties hereto.
6. That the Introducers provide sufficient details of the Clients to satisfy any Anti-Money Laundering legislation in the Isle of Man and that you provide sufficient details as to any regulatory body which you may be subject to and/or any current membership of such regulatory body; and verify the identity of all applicants. The Introducer confirms that they will abide by any relevant Anti-Money Laundering legislation.
7. That the Introducers will indemnify the Bank against any liability which you may incur by reason of any breach of legislation within their country of domicile. If there are any doubts in relation to the Introducers' activity constituting a breach under the legislation of the country of their domicile then we suggest that the Introducers seek independent advice before proceeding any further with the acceptance of the terms of this agreement.
8. An obligation on the Introducers to inform the Bank if the Introducers become aware of any material changes relating to the introduced clients.
9. Subject to the acceptance by the Introducers of the above terms and conditions the Bank will be prepared to pay commission (which includes any applicable VAT) to you for the successful introduction of acceptable business. However commission is only payable on selected investments and becomes payable once the account has been processed and sign-off complete. Our commitment to you is to send the commission payment to your company by the 15th day of the month, for correctly completed applications received prior to the 25th of the previous month.
